Scenario

1. Definition of risk – manner of event

The present scenario describes an unusual event that is based on the spread of a new pathogen. Although the scenario is based on the hypothetical pathogen "Modi-SARS", the properties of which are described in the information sheet (see appendix) and which is very close to the "SARS-virus", the past has shown that pathogens with novel properties that trigger a serious __ event can suddenly appear:

Then they say for example SARS-Coronavirus CoV:

A current example of a newly emerging pathogen is a corona virus ... closely related to SARS-CoV.

This __has been evidenced in six patients since summer 2012, two of whom died. One patient was treated in Germany and could be discharged as healed. In contrast to SARS-CoV, this virus does not seem to be transferable from person to person or only with great difficulty, so that the current risk assessment assumes that the risk of illness as a result of transmission from person to person is low.

2. Description of events

The hypothetical Modi-SARS is almost identical to the natural SARS-CoV. The incubation period, i.e. the time

from the transmission of the virus to a human being until the first symptoms of the disease, is usually three to __days, but can range from two to 14 days. Almost all infected people also fell ill. The symptoms are fever and dry cough, the majority of the patients have shortness of breath, changes in the lungs visible in X-rays, chills, nausea and muscle pain. Diarrhea, headache, rash (rash), dizziness, cramps and loss of appetite may also occur. The mortality rate among the affected * is high at 50%.

* Lethality describes the proportion of those who die as a result of the infection.

The transmission takes place mainly via droplets__, but since the virus can remain infectious [contagious] on [inanimate?] surfaces for a few days, an __ infection is also possible.

When the first symptoms appear, the infected people are contagious. This is the only difference in portability between the hypothetical Modi-SARS and the SARS-...

2.1 Place of appearance/ extension on areas

Where happens the event? Which place is concerned through the event?

The event occur global (essential Asian, North-America, Europe).

The spread in Germany takes place via a trade fair city in Northern Germany and a university city in Southern Germany. In the initial phase of the event [early stage], a total of ten cases are registered in Germany. Two cases are of particular importance here as they occupy key positions for dissemination ...

2.2 Time

At which time comes the event (time of the year, if applicable, time of day)

The event begins in February in Asia, but its dimension / meaning is only recognized there a few weeks later. The first infected Modi-SARS case occurs in Germany in April. This point in time forms the starting point of the present scenario.

2.3 Start of events

Which events led to this incident? How was the incident triggered?

The pathogen comes from the Southeast Asia, where the pathogen found in wild animals was transmitted to humans via markets. Since the animals themselves did not fall ill, it was not recognizable that there was a risk of infection.

Two of the first cases that are brought to Germany concern people who have been infected in the same South Asian country. One person flies to Germany the same evening to look after a stand at a trade fair in a Northern German city, the other person flies back to Germany a day later to resume studying in a Southern German university town after a semester abroad in China [...]

2.4 Period and course

How long continue the event and/or his direct effects?

New cases can be expected until a vaccine is available. A total period of three years is assumed for the present scenario, with the assumption that after this time a vaccine will be developed, released and available in sufficient quantities. In the course of the three years, the pathogen will change by mutation so that even people who have already had an infection will become susceptible to a repeated infection.

The extent of the damage is calculated as the sum for the entire period of three years. [...] Measures between day 48 and day 406 are generally described as effective.

The development of the spread with regard to the number of infected people is as follows:

Over the period of the first wave (day 1 until 411), a total of 29 million people fell ill in Germany, in the course of the second wave (day 412 until 692) a total of 23 million and during the third wave (day 693 until 1062) a total of 26 million. For the entire three-year period, at least 7.5 million deaths are expected as a direct result of the infection. In addition, the mortality rate of Modi-SARS sufferers and other sufferers, as well as those in need of long-term care will increase because they won't be able to receive adequate medical care or care due to the overloading in the medical and nursing sector.

Measuren [...] among others: Restrictions on fundamental rights, such as the <u>right to inviolability of the home</u>. The <u>basic right of freedom of the person</u> and <u>freedom of assembly</u> can also be restricted within the framework of necessary protective measures. In addition to these measures to be ordered directly by the medical officer, the Federal Ministry of Health can, by ordinance, order that threatened sections of the population <u>have to take part in vaccinations</u> (or other specific prophylactic measures [preventive measures]), which can limit the <u>right to physical integrity</u>.

In many places, the operation of critical infrastructures relies on highly qualified and specialized personnel, the failure of which can have far-reaching consequences (e.g. [...] air traffic control) and could lead to loss of supply or

large-scale bottlenecks. The following restrictions are based on the assumption that the filling of these <u>key positions</u> can still be guaranteed, i.e. that not too much staff will fall ill at the same time within the period considered.

Sector state and administration

Government and administration: Staff shortages can be compensated for by adjustments. Non-urgent and non-existential tasks are only dealt with subordinately, so that the areas of "public security and order" and "social affairs" in particular have access to sufficient human resources.

Parliament: Bundestag and government can continue their work.

Administration of justice can still be managed safely despite the staff shortages due to vacation__ and rescheduling.

Consequences for the safety good human: At the whole time 7.5 million deaths are expected as a direct result of the infection.

Drop in tourism.

Numerous goods and services are only made available to a few key producers worldwide. Thus, failures in the area of imported goods [...] can lead to bottlenecks.

Consequences for the safety good IMMATRIAL: It can be assumed that the uncertainty among the population, which can be expected in the event of a serious pandemic, also has an impact on public security and order.

In the present scenario, it is assumed that the majority of the population shows solidarity and tries to reduce the effects of the incident through mutual support and consideration. Similar solidarity behaviors have been observed in many other extreme situations. Nonetheless, it cannot be ruled out that increasing uncertainty and the feeling of being let down by the authorities and the healthcare system will promote aggressive [...] behavior.

Political consequences

There is a high level of public interest throughout the situation. The call for the authorities to act quickly and effectively will be heard early. The search for 'culprits' and the question of whether the preparations for the event were sufficient may arise during the first wave of infections. Whether there are demands for resignation or other serious political effects also depends on the crisis management and crisis communication of those responsible.
